Mr. Waters stated that staff is requesting to amend the permitted use table in Section 94-50 to include the use of park and recreation in the C-1A district along with the inclusion of said use as to be defined through amending Section 94-313. Mr. Waters stated that this has gone before the Planning Commission Board on September 27^{th,} and they voted all in favor of approving. AGENDA ITEM: New Business #2 Consideration to rezone Parcel 030A 030 consisting of 62.04 acres from M-1 Industrial to C-1A. This Parcel is located at 540 Lumber Company Road.

DISCUSSION:

Mr. Waters stated that if the Text Amendment is approved, staff is requesting the approval to rezone 540 Lumber Company Road (Hope House and Doris Wigington Park) to be rezoned to C-1A. Based on the analysis of this application, using the standards and criteria found in Section 94-246 of the Zoning Ordinance, staff recommends Approval of the request to rezone the property from M-1 to C-1A. Should the Mayor and City Council approve the rezoning request, it is expected that the applicant adheres to the minimum standards of the zoning ordinance. Mr. Waters stated that this has gone before the Planning Commission Board on September 27^{th,} and they voted all in favor of approving.

adoption of the ad valorem tax rate (millage rate) for 2022	

DISCUSSION:

Mrs. Williams stated that during a special called meeting on August 8th, staff presented advertising a tax increase by not rolling back the millage rate. After receiving the digest and presenting the current and 5-year history, it was concluded that not rolling back would result in a \$28,000 revenue increase over the roll back rate. It was determined that the city could adjust expenses to allow for rolling back the millage rate. Mrs. Williams stated that staff has advertised the current and 5-year history with a millage rate of 5.467. Mrs. Williams stated that if approved, staff will send the appropriate forms to the Pickens County Tax Commissioner's office.

CONCLUSION:

Mayor Lawrence called for a motion to approve Ordinance 2022-14 with the millage rate at 5.467. Councilmember Looney made a motion to approve. Councilmember Sneve provided a second. Motion to approve passed unanimously.
