Presentation: 2025 Tax Millage

Mayor called on Mr. Brandon Douglas to provide a presentation on the tax millage. Within the presentation there were examples of how the millage rate and HB581-Floating Homestead Exemption would affect both homeowners and property owners who live within the city limits of Jasper.
